- **All Documents must be submitted before arrival**
- Overnight Stalling / Event Stalling has the same requirements as monthly stalling except you don't need to get the vaccines
 - Overnight stalling has a **4-night maximum**.
- Access to arena is included with monthly rental, the office will give you a 4-digit code to use that will be reactivated every month after receiving payment.
- **PLEASE LOCK the arena gates after use**
- The Fairgrounds does not provide the type of insurance that you need to board, you will need to get it through someone else. If you do not know where to get it, we recommend Equisure Online.

 - Please keep your code to yourself

 - iii. The “Description of Operation” field must name Humboldt County Fairgrounds, Humboldt County Fair Association, CARF, District Agricultural Association, the State of California, and the County of Humboldt
 - iv. We require \$1,000,000.00 Commercial General Liability per Occurrence to be the minimum amount of coverage
- d. A copy of all current vaccines
 - i. 3 Way
 - ii. West Nile
 - iii. Flu
 - iv. Rhino
 - v. Rabies
- e. Initialed copy of the General Rules for Arena Use
- f. Release and Waiver of Liability Agreement
- g. Cleaning Deposit Refund Form

Arena Riding Pass:

- a. Certificate of Insurance
 - i. Must be effective for the boarding dates
 - ii. The “Certificate Holder” box must name Humboldt County Fair Association or Humboldt County Fairgrounds and include our address – 1250 5th Street, Ferndale, CA 95536
