Youth Contest Rules and Guidelines:

- **1.** The youth entries for the King Arthur Baking Contest are not live-judged.
 - **a.** As such, unlike the live-judged Open show, there will be no modifications or adjustments for admissions for the Fair.
 - **b.** If an exhibitor that qualifies for the Youth contest but wishes to be live-judged, they are welcome to apply for the Open entry instead, see the Open Home Arts department for more information however they cannot be simultaneously entered in Youth and Open.
- **2.** They will follow all rules as listed here as well as follow all direction provided in the Baked Foods show in Youth Home Arts.
 - **a.** If two rules contradict each other due to this contest, the rules herein will supersede the Baked Foods rules ONLY as applies to Class 11 in Divisions 310 and 311.
- **3.** The Youth King Arthur Baking Contest will use the American Judging System there will only be one winner for 1st, 2nd, and 3rd places for the purpose of the prizes listed above.
 - **a.** Divisions 310 and 311 will be judged together.
- **4.** Contestants may enter up to two pies in the contest. If contestants choose to enter two entries, each apple pie must not use the same recipe.

- **5.** Contestants must submit recipe card or copy of the recipe and it will be required on a 5x7 card or an 8½ x11 document to submit at entry deadline as listed in the Baked Foods show in the Youth Home Arts department.
- **6.** Pie pans must be plain with no identifying patterns or designs to ensure blind judgement.
 - **a.** Exhibitor information will be concealed by using numbers or another process to ensure there is no bias in judging. Once judging is completed, exhibitor's name may be revealed during the show as applicable with the rest of the Youth Home Arts department's procedure dictates.
- **7.** Staff and children of staff for the Humboldt County Fair Association are ineligible for the King Arthur Baking Contest.
